



BEDE Events Covid refund policy: 2021

This cancellation policy refers to cancellation due to the imposition of Covid-19 restrictions on the whole country or more locally the area in which the competition is due to run. As with most of not all events there is no Covid-19 insurance cover available so there is a shared risk. BEDE Events will undertake to mitigate the cost as far as is reasonably possible.

National BE Affiliated event:

Prior to ballot – 100%

Post ballot:

From ballot to 14 days prior to the first day of competition –	80% refund
From 13 days to 6 days prior to the first day of competition –	50% refund
From 5 days to 3 days prior to first day of competition –	30% refund
From 2 days to start of competition –	no refund

International Event (FEI) to incl. all national classes:

Prior to ballot – 100%

Post ballot:

From ballot to 14 days prior to the first day of competition –	60% refund
From 13 days to 6 days prior to the first day of competition –	35% refund
From 5 days to 3 days prior to first day of competition –	20% refund
From 2 days to start of competition –	no refund

Unaffiliated Event:

Prior to closing entries (CoE) or 21 days prior to event, whichever occurs first – 100%

Post CoE:

From CoE to 14 days prior to the first day of competition –	80% refund
From 13 days to 6 days prior to the first day of competition –	50% refund
From 5 days to 3 days prior to first day of competition –	30% refund
From 2 days to start of competition –	no refund

Onsite Stabling:

Thoresby - from confirmed booking and payment of stables by BEDE Events to the supplier, which is usually 10 - 12 days prior to when stables open, until 3 days prior to Stables open - 40% of stabling fee refunded.

Osberton - from confirmed booking and payment of stables by BEDE Events to the supplier, which is usually 12 days prior to when stables open, until 6 days prior to Stables open - 40% of stabling fee refunded.

Within 5 days of stables opening? - no refund

If after all costs incurred associated with stables there remains a positive balance, then an additional re-payment may be made e.g. unused/re-saleable bedding.

Hookup:

From confirmed booking and payment of generator/cabbling etc. BEDE Events will deduct all associated cost at the point of cancellation and then refund the balance between each booked hookup equally.

All refunds for stabling and hook up will remain at the discretion of the Organisers and a refund level for one event may not be the same as for another.

All entry refunds will be entry fee + VAT as paid at the time of entry but will not include any transaction fees imposed by the e-commerce or entry portal facilitator.

All start fees will be refunded 100% up until the point that specific days competition commences.

All refunds will be made within 21 days of the intended date of the event.

Consideration into creating this refund policy are almost entirely financial both for BEDE Events as a business and also those supplier whom will have committed in good faith to supplying the event and therefor the sport. These considerations are based on costs incurred rather than revenue/profit lost
